About Legal Aid

Since 1908, the Legal Aid Society has made a difference in our community by providing free, civil (non-criminal) legal assistance to low-income families and individuals to help them achieve economic security and family stability. That assistance can include legal information, advice, and representation. We will also make referrals to other organizations if our eligibility requirements are not met or we are unable to help.

In 2007, we established an affiliate, Legal Aid Society of Southwest Ohio, LLC, as we expanded our geographic reach. We serve people in seven counties in Southwest Ohio: Brown, Butler, Clermont, Clinton, Hamilton, Highland, and Warren. We coordinate services with the Volunteer Lawyers Project (VLP) to involve over 700 local attorneys in helping to resolve legal problems.

Our intake specialists handle all requests for service for the Legal Aid Society of Greater Cincinnati, the Legal Aid Society of Southwest Ohio, LLC, and the VLP.



Legal Aid Services to help clients:

Family Law and Domestic Violence

- Securing protection orders
- Resolving custody and visitation
- Representing in divorce proceedings
- Coordinating community services

Housing and Consumer

- Representing in eviction and foreclosure cases
- Preventing lockout or utility cutoff by landlords
- Obtaining repairs of unsafe conditions
- Improving neighborhood housing
- Resolving consumer debt & tax disputes

Employment and Income

- Resolving problems that interfere with job training or employment
- Securing unpaid wages
- Helping Veterans with disability claims or to prevent homelessness
- Expanding employment opportunities for persons with disabilities
- Securing income and medical benefits

Education and Child Safety

- Obtaining special education supports
- Preventing suspension and expulsion
- Addressing education needs of foster children
- Representing children in abuse, dependency and neglect cases
